**ORDINANCE NO. 2025-297**

**AN ORDINANCE OF THE TOWN COUNCIL OF THE TOWN OF  
MULBERRY, INDIANA AMENDING § 93.05  
RELATED TO ENUMERATION OF NUISANCES**

WHEREAS, Indiana Code § 36-1-3-4 provides a municipality all powers necessary to conduct its affairs, even if not expressly granted by statute;

WHEREAS, the Town of Mulberry, Indiana (hereinafter the "Town") believes it is in the best interest of its residents to enact ordinances for the regulation of health and sanitation, including nuisances, within the Town;

WHEREAS, the Town adopted Chapter 93 of the Town of Mulberry, Indiana, Code of Ordinances in Ordinance No. 68, on August 8, 1972, and amended Chapter 93 in Ordinance No. 91, Ordinance 157-2006, in July 2006, Ordinance No. 176-2010, on April 11, 2010, Ordinance No. 191-2013, on April 9, 2013, Ordinance No. 192-2013, on October 8, 2013, Ordinance No. 201-2015, on August 11, 2015, Ordinance No. 231-2019, on October 8, 2019, Ordinance No. 2022-060, on October 17, 2022;

WHEREAS, the Town determined § 93.05 of the Town of Mulberry, Indiana, Code of Ordinances should be amended as follows:

**NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE  
TOWN OF MULBERRY, INDIANA, AS FOLLOWS:**

1. The Town of Mulberry, Indiana, Code of Ordinances § 93.05 is hereby amended by revising and adding additional nuisances as follows:

**§ 93.05 ENUMERATION OF NUISANCES.**

It shall be unlawful, inside the corporation boundaries of the town, for any person, firm, partnership or corporation:


(S) To allow grass, weeds, shrubbery, trees, bushes or other growth to accumulate in such a manner that it blocks view of a public way such as an intersection of a road, street, alley or sidewalk and causes a hazard to those traveling on such road, street or sidewalk, or to place any objects in such a way that it blocks a public way, such as a road, street, alley, or sidewalk and causes a hazard to those traveling on such road, street, or sidewalk;


The remainder of § 93.05 shall remain in full force and effect as previously adopted.


2. This amendatory ordinance shall be effective upon passage, publication, and posting in accordance with Indiana law.




